### Enrollment and Session

- Selection of students for the program will be based on age. Older students will have first choice.
- High school dropouts are not eligible to enroll in driver education.
- Classroom instruction for **Fall Session 1** will begin Sept 18<sup>th</sup> and end Oct 24<sup>th</sup> or 29<sup>th</sup>.
- Classroom instruction for **Fall Session 2** will begin Nov 5<sup>th</sup> or 6<sup>th</sup> and end Dec 12<sup>th</sup> or 13<sup>th</sup>.
- The course will be in the afternoon for two hours, three days per week, immediately after school is dismissed, as follows:

- A roster of students scheduled for the 30 hours of classroom will be posted in each middle and high school before the scheduled class is to begin. This information will also be available on the Cumberland County Schools web site at [www.ccs.k12.nc.us](http://www.ccs.k12.nc.us). Click on the word students then click on Driver Education. Also students will receive a computerized phone message about a week before the class begins.
- A fee of \$65.00 or a reduced fee of \$32.50 shall be collected from each student. The fee must be in the form of a money order made payable to Cumberland County Schools. **(Personal checks will not be accepted). Please No Cash! This fee will be collected by the driver education teacher on the first day of class.** There are no exceptions or refunds! If the student does not bring the required fee on the first day of class, he/she will not be admitted to class.  
 In order to qualify for the reduced fee, **you must be enrolled in the free-and-reduced meal program with the Cumberland County Schools' Child Nutrition Services.** The student must bring a Letter of Approval from Child Nutrition along with the fee of \$32.50. Any student who does not have the Letter of Approval will be issued a "Student Eligibility" form which must be completed by a parent/guardian and returned to the Driver Education Instructor.
- **It shall be the responsibility of parents to see that the student is picked up PROMPTLY after class is dismissed.**
- **Students are expected to attend all class sessions.** There are no excused or unexcused absences in Driver Education.
- **Upon completion of the 30 hours classroom requirement,** students will be scheduled to complete their 6 hours of behind-the-wheel instruction on school day afternoons and/or on Saturday beginning with the oldest students. No absences are allowed for behind-the-wheel instruction. **Students will be notified by telephone when they are assigned to do their behind-the-wheel instruction.** Transportation to and from school for this phase must be provided by the parent.

**In order to register for the Fall Session 1 this application must be returned to your school**

**No later than: September 7, 2018!**

Applications for **Session 2** will be accepted through October 5, 2018
